

Tackling the Biggest Cases



Our fight to hold the makers of GenX accountable is being followed by CBS, NBC, and other major news outlets. Since 2017, we've been waging a massive class action against DuPont and The Chemours Company for contamination of the Cape Fear River water supply. These companies are responsible for toxic chemicals being released into the river for decades, poisoning the major water source for Wilmington and other areas. Tens of thousands of clients are counting on us to secure needed compensation and a measure of justice.



When four Blackwater contractors were pardoned for their roles in massacring Iraqi civilians, the media turned to us for answers. One of our attorneys represented the families of massacre victims in their quest for justice against Blackwater.*



And Hollywood has come calling about our first big case. CMNTY Culture Films has chosen a film on our landmark civil rights victory as its debut production project. The movie recounts the long odds and logistical challenges that had to be overcome if our firm was to secure justice for 18,000+ farmers after decades of racial discrimination by the federal government.

At our firm, coworkers at all levels care. Hierarchy isn't our thing. Helping out when we can, some of us or all of us — that's who we are.





\$1.25 Billion Historic Class Action Against the U.S. Government

We helped lead one of the largest civil rights cases in U.S. history. In 2010, the case culminated in a \$1.25 billion settlement designed to give Black farmers long-awaited compensation after years of egregious discrimination by the USDA.

The years of hard work, massive logistical challenges, and hard-won experience allowed us to achieve some justice for people who had so much taken from them. The presiding judge complimented our work in his opinion:



Using the Law to Uplift Others

Some of our major public service initiatives include:

Durham Eviction Clinic

The firm's gift to Duke Law School's Civil Justice Clinic allowed for the creation of an eviction diversion program in partnership with Legal Aid of North Carolina. The program's success in diverting wrongful evictions ultimately prompted the city of Durham to begin funding it.



Farrin Public Interest Fellowship

A second major gift to Duke Law School endowed a public interest fellowship for new lawyers. New graduates can now use their skills to increase access to justice for underserved communities while still being fully funded and supported by the fellowship.



Research Into Long-Term Poverty Solutions

Jim and the firm are primary contributors to this ongoing research project at UNC Law School, which studies the criminalization of poverty in North Carolina. We hope the results will lead to better laws and treatment for impoverished people in our state.



Pro-Bono Work

Our attorneys contribute more than 1,500 hours in pro bono work a year. Four of our attorneys were recognized in 2021 with induction to the North Carolina Pro Bono Honor Society for their dedication to pro bono legal service.



Supporting Underserved Students

The firm partners with Cristo Rey Research Triangle High School, a school for economically underserved students. By becoming a Corporate Work Study Partner of the school, we help provide professional work experience to minority students. The innovative program is proven to help remove institutional barriers for participating students.

- 6. Interaction and support for new attorneys from the day they step in the door, including training plans and regular meetings for Associate Attorneys to provide feedback, advice, and encouragement




